

B EVERETT JORDAN LAKE, US ARMY CORPS OF ENGINEERS (USACE), FIREARMS SAFETY INFORMATION MAP

B Everett Jordan Lake and the surrounding federal property are under the stewardship of the US Army Corps of Engineers (USACE). The majority of the property is leased to the State of North Carolina and managed by various state and local government agencies. At Jordan Lake the possession and use of firearms for the purposes of hunting and fishing (bow fishing) are authorized in certain areas.

The possession and discharge of firearms on federal property at Jordan Lake is subject to the following:

36 CFR 327.13 (a) The possession of loaded firearms, ammunition, loaded projectile firing devices, bows and arrows, crossbows, or other weapons is prohibited unless: (1) In the possession of a Federal, state or local law enforcement officer; (2) Being used for hunting or fishing, with devices being unloaded when transported to, from or between hunting and fishing sites. (3) Being used at authorized shooting ranges;*

The above federal regulation applies to all areas at the lake, regardless of managing agency. However, additional restrictions may apply in leased areas. The requirements for each management area are listed below

• **USACE Management Areas - Jordan Dam and Tailrace, Poe's Ridge Recreation Area: 919-542-4501**

- Possession and discharge of firearms for hunting and fishing in compliance with 36 CFR 327.13 (a) are authorized, except in restricted areas.
- **USACE Firearms Safety Zone Restriction** - The discharge of firearms, projectile firing devices, bows and arrows, crossbows, or other weapons within, into, or across designated Firearms Safety Zones is prohibited.
 - The safety zone extends 100 yards (300 feet) from the shoreline.
 - The safety zone restriction prohibits the discharge of firearms.
 - The restriction does not prohibit the transport of firearms in compliance with 36CFR327.13(a).
- Firearms are prohibited inside federal facilities.**

• **NC Wildlife Resources Commission (NCWRC) - Game Lands: 919-542-4662**

- Possession and discharge of firearms for hunting and fishing in designated areas in compliance with NCWRC Regulations and 36 CFR 327.13 (a) are authorized.
- Reference Game Land maps and regulations for information on the location of safety and archery only zones on Game Lands

• **Jordan Lake State Recreation Areas, NC Division of Parks and Recreation (NCDPR): 919-362-0586**

- Hunting and fishing with firearms are prohibited.
- Firearms are prohibited.**

• **NC Forest Service (NCFS) : 919-542-1154**

- Hunting and fishing with firearms are prohibited.
- Firearms are prohibited.**

• **Wake County Parks - American Tobacco Trail (ATT): 919-387-2117**

- Hunting and fishing with firearms are prohibited.
- Firearms are prohibited along the ATT and at ATT trailheads on government property at Jordan Lake except for firearms in the possession of a Federal, state or local law enforcement officer, and unloaded firearms being transported to, from or between hunting and fishing sites in compliance with in compliance with 36 CFR 327.13 (a) and NCWRC Game Lands Regulations.

* There are no authorized shooting ranges at Jordan Lake.

** Except for firearms in the possession of a Federal, state or local law enforcement officer
