D. ADDITIONAL COMMENTS TO SUPPORT JD:

The stream channels in the project site are unnamed tributaries (UTs) to Tulula Creek and the open waters is an impoundment of the UTs to Tulula Creek. The UTs of Tulula Creek flow into Tulula Creek and then flow into the Cheoah River, a traditionally navigable water (TNW). The stream channels and impoundment in the project site exhibit indicators of ordinary high water marks, are blue line features on the U.S. Geological Survey 7.5 minute topographic quadrangle map, and have perennial flow. The noted
